

RESOLUTION NO.31-07

**A RESOLUTION ENDORSING AN AMENDMENT TO THE SOUTH BEND AND
ELKHART/GOSHEN FY2006-2008 and FY2008-2012 TRANSPORTATION
IMPROVEMENT PLANS**

WHEREAS, the SAFETEA-LU Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy of Users (2005) designating joint Federal Highway Administration/Federal Transit Administration rules and regulations, under Section 134, Title 23 of the US Code (h) and CRF, Part 450, Sub-part A, of the previous STAA act require the annual preparation of a Transportation Improvement Program by the designated Metropolitan Planning Organization(s) as a part of the transportation planning process in urbanized areas of 50,000 or more population; and

WHEREAS, the Michiana Area Council of Governments (MACOG) being the duly designated Metropolitan Planning Organization for the South Bend and Elkhart/Goshen Urbanized Areas, in cooperation with local governmental units and implementing agencies within the urbanized areas, has prepared a FY2006-2008 Transportation Improvement Plan (TIP), which consists of improvements recommended in the MACOG Region.

WHEREAS, the MACOG Policy Board from time to time receives and amends its Transportation Improvement Programs,

BE IT THEREFORE RESOLVED, that the South Bend and Elkhart/Goshen FY2006-2008 and FY2008-2012 Transportation Improvement Programs (TIP) are amended to include the following:

Amendment: FY2006-2008 and FY2008-2012 Transportation Improvement Programs

Amend the FY 2006-2008 and FY 2008-2012 Transportation Improvement Programs to include the following transit project changes for the South Bend PTC (Transpo):

Change project wording from "Site preparation, Pre-Construction and Property Acquisition for Operations Facility" to "Design and Construction of Administrative Facility." There is no change in the dollar amount. This is **Section 5307** Urbanized Area Formula Funding.
